BE IT ENACTED BY THE QUORUM COURT OF COUNTY OF MARION, ARKANSAS; AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE PROVIDING FOR AND ADOPTING A BUDGET FOR MARION COUNTY, ARKANSAS FOR THE PERIOD BEGINNING JANUARY 1, 2022, AND ENDING DECEMBER 31, 2022.

ARTICLE 1. ANNUAL BUDGET ADOPTED BY REFERENCE. The annual budgeted for calendar year 2022 identified as "ANNUAL BUDGET, MARION COUNTY, ARKANSAS" dated December 30, 2021, is hereby adopted by reference. A copy of said budget shall be filed in the office of Circuit/County Clerk and shall be available for inspection and copying by any person during normal office hours.

ARTICLE 2. NONRESTRICTED EXPENDITURES CATEGORIES. Expenditure of funds appropriated by this Ordinance shall not be restricted to the line-item expenditure codes comprising the major categories of expenditures – Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service – but shall be restricted to office/departmental expenditures within the above enumerated major categories of expenditures except for funds appropriated for personal salaries and wages and related employee's benefits. Personnel expenditures shall not exceed the dollar amounts, numbers of employees and salary or wage rates specified in the annual budget or an amendment thereof.

ARTICLE 3. PERSONAL SERVICE SCHEDULE AND WAGES. Wages for county employees are based on the various responsibilities, duties, licensing requirements and length of service. The Personal Service and Wage Schedule is attached. Each Elected Official is responsible for preparing the job descriptions for each position(s) within their department(s). In addition, each elected official is responsible for submitting whatever additional information requested by the Personnel Committee and Budget Committee before any new positions are added to this schedule. In addition, hiring employees due to vacancies or salary increases required approval from the budget committee. Note: During times of Public Emergencies effecting Marion County, employees classified as Public Safety Employees, are exempt from this Article. Public Safety Employees are defined as Law Enforcement Personnel Office of Emergency Services Management (OEM), 911 Offices, Road Department and other department's personnel as determined by the Marion County Judge.

<u>Article 4</u>. **EXPENDITURES RESTRICTED TO SPECIFIED FUND.** No expenditures of appropriated funds shall be made from any fund other than the fund specified in this Ordinance or an amendment therein.

<u>Article 5.</u> **REVENUE AND APPROPRIATIONS.** Documentation is attached to this Ordinance and incorporated herein.

Article 6. TRANSFERS. Included in this budget are two (2) conditional transfers of County General Funds. The first one is a conditional transfer by the Treasurer of up to \$418,000.00 from County General Fund to the Department of the Sheriff's Law Enforcement Fund on a "As Needed Basis"

condition and Comptroller to appropriate into various line items. The Second transfer of County General Funds is the conditional transfer by the Treasurer of up to \$82,000.00 to the County Judge's E911 Department Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. Other than these two conditional transfers of funds any transfers of monies between various funds of the County or between the major categories of expenditures -Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service – shall be made only with prior approval of the Marion County Quorum Court. Provided, however all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

Article 7. SEVERABILITY. If any provisions of this Ordinance or the application thereof any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provisions or application, and to this end, the provisions of this Ordinance are declared to be severable.

Article 8. This ordinance being necessary for the protection and preservation of public health and safety, an emergency is declared to exist, and this Ordinance shall be in force and shall take effect upon passage and publication.

BE IT ENACTED BY THE QUORUM COURT OF COUNTY OF MARION, ARKANSAS; O.C. AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET AND NUMBERS AND COMPENSATION, ORDINANCE 2021-124, THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR 2022 FOR MARION COUNTY, ARKANSAS TO CORRECT AND UPDATE CHANGES IN PROJECTED REVENUE AND EXPENDITURES.

WHEREAS, on December 30, 2021, the Marion County Quorum Court Enacted Ordinance No. 2021-124 adopting the ANNUAL BUDGET, MARION COUNTY ARKANSAS by reference. A copy of said budget was filed in the office of Circuit/County Clerk and is available for inspection and copying by any person during normal office hours.

Article 6. TRANSFERS. Included in this budget are two (2) conditional transfers of County General Funds. The first one is a conditional transfer by the Treasurer of up to \$418,000.00 from County General Fund to the Department of the Sheriff's Law Enforcement Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. The Second transfer of County General Funds is the conditional transfer by the Treasurer of up

to \$82,000.00 to the County Judge's E911 Department Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. Other than these two conditional transfers of funds any transfers of monies between various funds of the County or between the major categories of expenditures -Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service – shall be made only with prior approval of the Marion County Quorum Court. Provided, however all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

As Amended:

Article 6. TRANSFERS. Included in this budget are three (3) conditional transfers of County General Funds. The first one is a conditional transfer by the Treasurer of up to \$507,170.60 from County General Fund to the Department of the Sheriff's Law Enforcement Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. The Second transfer of County General Funds is the conditional transfer by the Treasurer of up to \$48,080.22 to the County Judge's E911 Department Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. The third one is a conditional transfer by the Treasurer of up to \$301,572.67 from County General Fund to the Department of the Sheriff's Jail Maintenance Fund on a "As Needed Basis" condition and Comptroller to appropriate into various line items. Other than these three conditional transfers of funds any transfers of monies between various funds of the County or between the major categories of expenditures -Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service - shall be made only with prior approval of the Marion County Quorum Court. Provided, however all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

<u>Article IV</u>. **SEVERABILITY**. If any provisions of this Ordinance or the application thereof any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provisions or application, and to this end, the provisions of this Ordinance are declared to be severable.

<u>Article V.</u> This ordinance being necessary for the protection and preservation of public health and safety, an emergency is declared to exist, and this Ordinance shall be in force and shall take effect upon passage and publication.
