QUORUM COURT OF PRAIRIE COUNTY, ARKANSAS

ORDINANCE NO. 2022-8

AN APPROPRIATION ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR 2023 DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF PRAIRIE COUNTY, ARKANSAS THAT:

**Section 1. THE ANNUAL BUDGET ADOPTED BY REFERENCE.** The annual budget for the calendar year 2023 is hereby adopted by reference. A copy of said budget shall be filed in the office of the County Clerk and shall be available for inspection and copying by any person during normal office hours.

**Section 2. NONRESTRICTED EXPENDITURE CATEGORIES.** Expenditure of funds appropriated by this Ordinance shall not be restricted to the line-item expenditure codes comprising the six major categories of expenditures-personal services, supplies, other services and charges, Outlay, debt service and interfund transfers-but shall be restricted to office/departmental expenditures except for funds appropriated for personal salaries and wages and related employee benefits. Personnel expenditures shall not exceed the dollar amounts, number of employees, and salary or wage rates specified in the annual budget or an amendment thereto.

**Section 3. EXPENDITURES RESTRICTED TO SPECIFIED FUND.** No expenditure of appropriated funds shall be made from any funds other than the fund specified in this ordinance or an amendment thereto.

**Section 4. TRANSFERS.** Any transfer of monies between the various funds of the county or between the four major categories of expenditures shall be made only with the prior approval of the Prairie County Quorum Court, provided however, all transfers budgeted for in the annual budget or an amendment thereto shall be exempt from the provisions of this section.


**Section 6. SEVERABILITY.** If any provision of this Ordinance or the application to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provisions application. To this end, the provisions of this Ordinance are declared to be severable.

**Section 7. EMERGENCY.** The proper and appropriate use of the funds of the county is of great importance to the public health, safety, and welfare of its citizens. An emergency is therefore declared and this Ordinance being necessary for the preservation of the public health, peace, safety, and welfare shall be in full force and effect from and after its passage.
